- Right to be attended by a professional.
- Right to receive quality treatment.
- Right to be treated the same as everyone.
- Right to receive all available supports from the center
- Right to participate in the center.

RIGHTS AND DUTIES OF THE RELATIVES OF THE CAIT

RIGHTS

Family members or legal representatives have the right to:

- Right to get them in the center.
- Right to submit to workers.
- Right to attend your relative's sessions.
- Right to participate in the evaluation of your relative.
- Right to know the result of the evaluation of your relative.
- Right to take part in decisions about the treatment of your family member.
- Right to be informed of the treatment that your relative is receiving.
- Right to know the treatment schedule of your family member.
- Right to request user evolution information.
- Right to be informed of all decisions adopted.
- Right to receive family support.
- Right to be asked for authorization on everything related to your child.
- Right to know that the treatment of your family member is part of a teaching or research project.
- Right to the fact that center workers treat them well.
- Right to the fact that the other families treat them well.
- Right to be treated as everyone.
- Right to participate in center activities.
- Right to attend other services from other professionals in other centers ..
- Right to a quality center.
- Right to request seconds diagnoses in other services.
- Right to communicate your complaints or claims.
